PURPOSE

- Accurately planning and performing comprehensive System, Regression, Integration and UAT testing on behalf of the business within agreed timescales.
- Deliver allocated project tasks on time (against Project Plan and Test Schedule) to the required quality standard, ensuring appropriate preparation for these is completed so as not to impact test and project milestones.
- Provide evidence of regular testing updates to the Business Analyst & Project Manager, participate in update meetings, communicating progress of testing assigned at the agreed intervals or when issues/new information arises.

- Participate in implementation activities and ensure sufficient preparation completed throughout the implementation by liaising with other stakeholders
- Proactively seek opportunities to increase skills and knowledge, always working towards improved Test Efficiency

Other Responsibilities

- Ensure all activities meet and integrate with organisational requirements for quality management, health and safety, legal stipulations, environmental policies and general duty of care;
- Protect the culture and standards of the Society in respect of its dealing with colleagues, members and external relationships.
